In 2018, Paul was named a “Top 40 Under 40” lawyer by the Daily Journal, as one of only 20 lawyers selected from Southern California.

In 2021, Paul represented a healthcare district in the trial of a high-profile case in which the plaintiff claimed \$9.1 million in lost rental income damages as a result of a multi-year dispossession from a 60,000 square foot office building. Paul and his team achieved a complete defense verdict and a judgment in favor of the healthcare district for more than \$4 million.

Additional highlights of Paul’s recent work include:

- Successfully briefed, argued, and prevailed in the United States Court of Appeals for the Ninth Circuit, achieving dismissal of 8-figure claims against a public airport in November 2017. *SilverWing at Sandpoint, LLC v. Bonner Cty.*, 2017 U.S. App. LEXIS 21970 (9th Cir. 2017).
- Won a unanimous reversal in a state supreme court following the trial court’s denial of a motion for judgment notwithstanding the verdict.
- Successfully served as lead trial counsel in a two-week jury trial and obtained a verdict limiting exposure to less than 1% of the amount sought by the Plaintiff. (Additional trial experience includes representing a Fortune 100 company in a three-week jury trial and serving as first chair and second chair in bench trials and jury trials.)
- Represented a leading aircraft maintenance company in state, federal, and Part 16 actions over an airport hangar lease dispute, resulting in a complete victory for the client on summary judgment and an award of more than \$1.4 million in attorney’s fees.
- Represented a leading national energy company in regulatory compliance matters related to a wind energy project.
- Successfully represented a Beijing-based client in obtaining a high-dollar figure judgment in litigation in the United States District Court for the Central District of California.

- Advised a mining transportation and logistics company on FAA regulatory compliance matters related to the operation of large delivery drones.
