Mr. Zadek is a past Chair of the Commercial Financial Services Committee of the Section on Business Law of the American Bar Association. He served on the Executive Committee of the Business Law Section of the State Bar of California and Chaired its Uniform Commercial Code Committee.

Mr. Zadek has served as an attorney advisor on the American Law Institute Committee to Revise the Restatement of the Law of Suretyship, and was an advisor to the Drafting Committee on Revision of Article 9 of the Uniform Commercial Code.

For the past 18 years, Bob has been the keynote speaker at the Annual Convention of the International Factoring Association, the largest factoring trade association in the world. Bob has also been a frequent panelist at the Convention. Every year the IFA offers Bob's two-day, course "The Law and Business of Factoring," attended by seasoned factoring executives, newcomers to the industry and their counsel. The forms which Bob distributes at this presentation have become the standard forms in the industry.

Mr. Zadek is regularly retained as an expert witness in factoring and commercial loan litigation, and has testified at jury and bench trials on many occasions.

In addition, he teaches workshops across the country on loan documentation issues.
